### Personal Data Consent Form

1. The Yan Oi Tong Jockey Club Community and Sports Centre is operated under Yan Oi Tong Limited (YOT) which has the right to collect your personal data for service application usage. All personal data collected will be handled in accordance with the Personal Data (Privacy) Ordinance. YOT will not transfer, sell or trade your personal data including, but not limited to, your name, telephone number, email address and correspondence address to third parties except for specific classes of data transferees as listed below:
  - a. YOT staff, volunteers, services units and departments; and
  - b. YOT authorised insurance companies, doctors, legal advisors and/or other services providers; and
  - c. Hong Kong SAR Government authorised or legally empowered departments and organisations.
2. I understand that provision of my personal information is on a voluntary basis. If I fail to provide adequate personal information, YOT might not be able to process my application which might result in a delay in service delivery. I shall take full responsibility for such consequences.
3. I understand that I should ensure the accuracy of the personal information I provide. Should there be any changes or updates, I shall notify YOT as soon as possible. If I fail to declare changes in my personal information, I shall not hold YOT responsible for any delay in service delivery.
4. I understand that if the personal data I provide involves another person, I should obtain his/her prior approval.
5. I am certain that YOT will destroy the personal data I provide in 2 to 7 years' time upon completion of service.

Except for those areas that fall within the exemption stipulated in the Personal Data (Privacy) Ordinance, I fully understand that I have the right to request access to and the correction of my personal data held by YOT. YOT reserves the right to charge an initial handling fee of HK\$ 70 for processing my data access request. A charge of HK\$2 per black and white page will be applied should I request a printed hard copy. YOT may use your personal data for necessary communications, information delivery, service promotions, fundraising, volunteer recruitment, collection of opinions and any other activities related to YOT.
